Crown Lease in Perpetuity 1640 held by Apostleship of the Sea over Lot 5260, Town of Darwin (Stella Maris) was surrendered on 11 December 2007. This site is now managed by this Department. In regards to the lease granted by DCC to Apostleship of the Sea over the adjoining part Lot 6597, Town of Darwin, given that Apostleship of the Sea no longer have an interest in Stella Maris it seems reasonable that DCC cancel this lease. This decision, however, rests with DCC.

We are currently awaiting a decision by Cabinet as to the future of Lot 5260. Until we are advised of this decision we are unable to comment on what will happen to this site.

Whilst we are awaiting this decision Crown Land Management have secured the buildings at Lot 5260 as much as possible, have a security contractor checking the buildings twice a night and have a grounds maintenance contractor mowing the area and maintaining the gardens every three weeks, to ensure that the site is as aesthetically pleasing as possible to people utilising Traveller's Walk. Our grounds maintenance contractor currently mows part Lot 6597 and we are happy to continue this service for DCC at the present time.
